#### Overview

At Alamogordo Public Schools, we believe that every child should have access to technology to develop digital skills that will prepare them for a successful future in education and the workplace. As a part of our commitment to providing students, teachers, and staff with access to digital resources that will promote educational excellence, innovation, and communication, we provide computing systems, internet connectivity, and a variety of hardware and software otherwise known as, electronic information services (EIS). Before being permitted to use (EIS) provided by the school district, students and staff must review the Acceptable Use of Technology Resources Agreement and agree to the terms of use. Students will be required to review the policy with a parent or guardian as cosigner.

#### **Internet Safety**

In effort to protect our students from potentially harmful or inappropriate internet materials, APS utilizes technology protection measures. The internet filtering system in place on all school computers and content controls used by APS meet federal standards established in the Children's Internet Privacy Act (CIPA). Additionally, it is the responsibility of APS staff to actively monitor student use of (EIS) when on the school premises. APS expects all users of (EIS) to be responsible, ethical, and safe digital citizens.

#### **Digital Citizenship**

APS teachers and staff members are committed to educating students on how to use the internet and technology safely and responsibly. Each student will receive instruction on ethical online behavior, appropriate online communication with others, how to recognize and report cyberbullying, and overall internet safety.

#### **Acceptable Use.** *Each user must:*

- Use the (EIS) to support personal educational objectives consistent with the educational goals and objectives of the School District.
- Agree not to submit, publish, display or retrieve any defamatory, inaccurate, abusive, obscene, profane, sexually oriented, threatening, racially offensive, or illegal material.
- Abide by all copyright and trademark laws and regulations by obtaining written permission from the author or publisher to use copyrighted material as well as refrain from plagiarizing other's work. (agree not to submit other's work as your own.)



#### (Cont.)

- Not reveal home addresses, personal phone numbers or personally identifiable data unless authorized to do so by designated school authorities.
- Understand that electronic mail or direct electronic communication is not private. All messages, whether composed, sent, received, or housed in the email account provided by APS are subject to be monitored by district employees.
- Not use the network in any way that would disrupt the use of the network by others.
- Understand that users may be held responsible for any intentional damages to the (EIS) provided by the district.
- Not attempt to harm, modify, add/or destroy software or hardware nor interfere with system security.
- Not use the (EIS) for commercial purposes.
- I understand that inappropriate use may result in cancellation of permission to use the educational
  information services (EIS) and appropriate disciplinary action up to and including expulsion for
  students.

In addition, acceptable use for District employees is extended to include requirements to:

- Maintain supervision of students using the (EIS).
- Agree to directly log on and supervise the account activity when allowing others to use District accounts.
- Take responsibility for assigned personal and District accounts, including password protection.
- Take all responsible precautions, including password maintenance, file and directory protection measures, to prevent the use of personal and District accounts and files by unauthorized persons.

#### **Policy Violations:**

• I understand that inappropriate use or any violations of this user agreement may result in cancellation of permission to use the educational information services (EIS) and appropriate disciplinary action up to and including expulsion for students.

#### Personal Responsibility.

I will report any misuse of the (EIS) to the administration or system administrator, as is appropriate. I understand that many services and products are available for a fee and acknowledge my Network etiquette.



#### Network Etiquette.

I am expected to abide by the generally acceptable rules of network etiquette. Therefore, I will:

Be polite and use appropriate language.

• I will not send, or encourage others to send, abusive messages threatening another person or participate in cyber bullying.

Respect privacy.

• I will not reveal any home addresses, personal phone numbers, or personally identifiable information.

Avoid disruptions.

• I will not use the network in any way that would disrupt use of the systems by others.

#### Services.

The School District specifically denies any responsibility for the accuracy of information. While the District will make an effort to ensure access to proper materials, the user has the ultimate responsibility for how the electronic information services (EIS) is used and bears the risk of reliance on the information obtained.

### NOTICE REGARDING PARTICIPATION IN VIRTUAL SMALL GROUP LESSONS/TELESERVICES/TELEPHONIC INSTRUCTION

Dear Parent.

- I agree and consent to my child's participation in virtual small group lessons/teleservices/telephonic instruction
- I agree and consent to any inadvertent release of confidential information about my child that may occur as the result of virtual small group lessons/teleservices/telephonic instruction.
- I agree and consent to the audio or video recording of my child's image and/or voice by the school provider conducting the virtual/teleservice/telephonic session for educational purposes only.

Through your child's participation in these activities, you further acknowledge and agree to abide by the following standards and expectations:

- You may observe your child and other students during small group virtual lessons.
- During the time that you observe a small group virtual lesson, you agree to not interrupt instruction by talking to the teacher or any other person in the virtual classroom or instruct -tional space, and you agree to refrain from any activity that may disrupt the session and will discontinue any such activity if requested by the school provider.
- You agree to not audiotape, videotape, record, or photograph, in any manner, the virtual/ teleservices/telephonic group lesson or any communications related to the set up or closing of the session by the school provider.
- You agree to respect every child's right to privacy, and agree to not discuss your observations or any confidential information inadvertently obtained during the virtual group lesson.
- If you have concerns about your child or other students observed, you agree to only discuss your concerns with your child's teacher or therapist, case manager, and/or campus administrator.
